2007 PICNIC SEASON

The picnic season in Minneapolis parks runs April 15 through October 15. To allow families, organizations and individuals to plan for the use of picnic facilities in the Minneapolis park system, a permit is required. Reservations begin Monday, January 2, 2007 at 7:30am. Reservations will be accepted in person, on a first-come, first-serve basis at the Minneapolis Park and Recreation Board Special Services/Permits Office, 2117 West River Road.
