## **General Reservation Information**

- Return your group request 2 weeks prior to your visit. It can be mailed or faxed to Minneapolis Park and Recreation Board, Attn: Aquatic Facility Reservation, 2117 W River Rd N. - This reservation requires approval.
- Reservation times are limited to 1:00pm-7:00pm Fridays only.
- It is the policy of the Minneapolis Park & Recreation Board that No person shall smoke or use any tobacco product within one hundred (100) feet of the entrance to any Minneapolis Park & Recreation Board owned or leased building and inside the designated perimeter or within one hundred (100) feet of any playground, beach, wading pool, or water play area.
- All wardrobe and clothing must follow facility policy; see attached.

### **Admission Procedure:**

- All group members must arrive and enter the park at the same time.
- Group rosters are not maintained by the facility staff.

### **Cancellations:**

### **Re-entry:**

Coolers and outside food are not permitted. Guests are welcome to picnic outside of the facility and reenter. Hand stamps are required for reentry. Wrist bands will be issued for reentry which will have a time requirement.

### **Webber Pool Rules**

1. No food or drink is allowed. Guests are welcome to picnic outside of the facility and re-enter.
2. Appropriate swim attire must be worn in the park; see attachment.
3. Lifejackets approved by the United States Coast Guard will be the only flotation device that can be used.
4. Water toys, sand toys, noodles, water wings and balls are not allowed to be brought into the facility.
8. Guests who are not toilet trained will be asked to be in a swim diaper. Swim Diapers are available for purchase for \$1
9. Children under the age of 8 must be accompanied by an adult at all times.  
For groups with children ages 12 and under, a 1 adult to 8 children ratio is recommended.
10. Webber Staff will not hold guests' personal belongings. The MPRB is not responsible for patron items.  
Free lockers are available on a first come first serve basis; no locks are provided by Webber staff.
11. Webber Pool is a tobacco-free facility.
12. Wildlife is to be enjoyed. Please do not pick-up or disturb any of the local habitat as this is there home too  
Patrons must shower before entering the pool  
Pets are not allowed inside the pool area

## **KEEP IT CLEAN, KEEP IT OPEN**

This pool is not disinfected with chemicals. With good hygiene and healthy swimming practices, we can all help keep the pool open.

1. Swimmers must shower before entering the pool.
2. Don't swim if you have open sores or are sick.
3. No food, beverages, tobacco, pets or glass allowed in pool facility; no street shoes in pool.
4. Guests who are not toilet trained must wear a swim diaper.
5. Youth 12 & under must be accompanied by an adult, age 18 & over.
6. Children under 8 years old must be supervised by an adult at all times.
7. Only United States Coast Guard approved lifejackets may be worn.
8. Inflatable articles, balls and water wings are not allowed.
9. Horseplay, spitting, pushing, running and any other unsafe behaviors are not allowed.
10. During designated water safety breaks, all guests are required to exit the water.
11. Staff has the right to remove any individuals in violation of Pool Rules or MPRB and City Ordinances.
12. Obey staff and lifeguards at all times.
13. The pool will not open if the temperature is 65 degrees Fahrenheit or below.
14. Pool users are responsible for their personal items.
15. The MPRB is not responsible for any lost or stolen items.

Nylon, lycra, polyester  
Silicone or latex  
Swim Diapers  
White Cotton

**These types of fabrics are NOT allowed in the water:**

Colored Cotton    Wool  
Denim (jeans)    Corduroy  
Leather    Undergarments  
Disposable or Cloth Diapers
