



North Service Area Master Plan Community Advisory Committee MEETING NOTES: CAC #9

June 26, 2018, Folwell Park

Approximately 20 members of the general public attended the meeting

MPRB Staff and Consultants Present: Adam Arvidson, Dan Elias, Siciid Ali (MPRB); Brad Aldrich, Emily Neuenschwander (Confluence)

1. Adam Arvidson provided a **welcome and an overview** of the project process to date, along with a timeline for final approval.
2. MPRB staff and consultants presented the preferred concept for each park that was determined to need further discussion. The general public and CAC members discussed each park in turn. *NOTE: in the interest of making these notes available in a timely fashion, only the results of the discussions are related here. More comprehensive notes will be made available when time permits.*
 1. Hall Park: previous **consensus**.
 2. Farwell Park: previous **consensus**
 3. North Commons Park: previously **referred to the North Commons Work Group**
 4. Farview Park: previously referred to an **additional Farview-focused community meeting**
 5. Shingle Creek Regional Trail / Creekview / Humboldt Greenway / Shingle Creek Park: CAC Chair Palmer suggested that these parks be discussed after the following three, for consideration of time efficiency. The CAC agreed with this idea.
 6. Sumner Field Park: The alternate preferred concept (without parking lot) was considered to have **consensus**.
 7. Victory Prairie and Dog Park: A combination of both alternate concepts (with trail loops within the park and a trail connection outside the dog park fence) was considered to have **consensus**.
 8. Perkins Hill Park: The alternate preferred concept (without parking lot) was considered to have **consensus**.
 9. Shingle Creek Regional Trail / Creekview / Humboldt Greenway / Shingle Creek Park: Alternate preferred concept B (with the skate park near the recreation center) was considered to have **consensus**.
 10. Bassett's Creek Park: After robust discussion, this park was **referred back to the Bassett's Creek Work Group** for further discussion.
 11. Bryn Mawr Park: After robust discussion, this park was **referred back to the Bassett's Creek Work Group** for further discussion.
 12. North Commons Park: not discussed
 13. Farview Park: not discussed

NOTE: The order was selected randomly. Hall Park was placed first because the design team will be bringing back a new design for review. Bassett's Creek and Bryn Mawr were placed last to allow for a work group meeting to take place prior to consideration on the 26th.

The meeting was adjourned at approximately 8:15.
