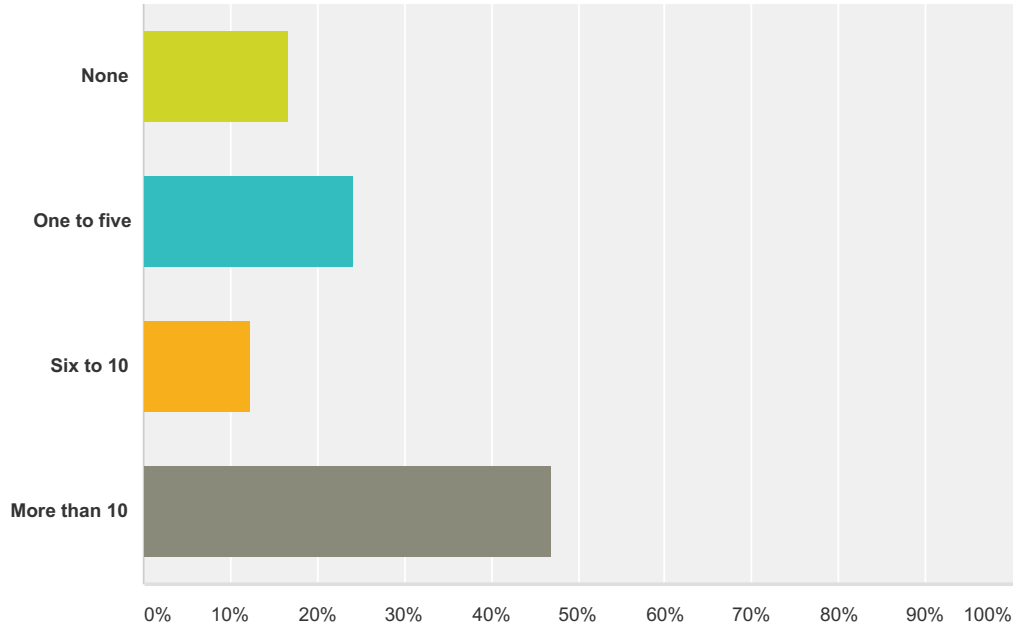

Q2 How often have you visited / used the facilities at Hiawatha Golf Club in the past two years?

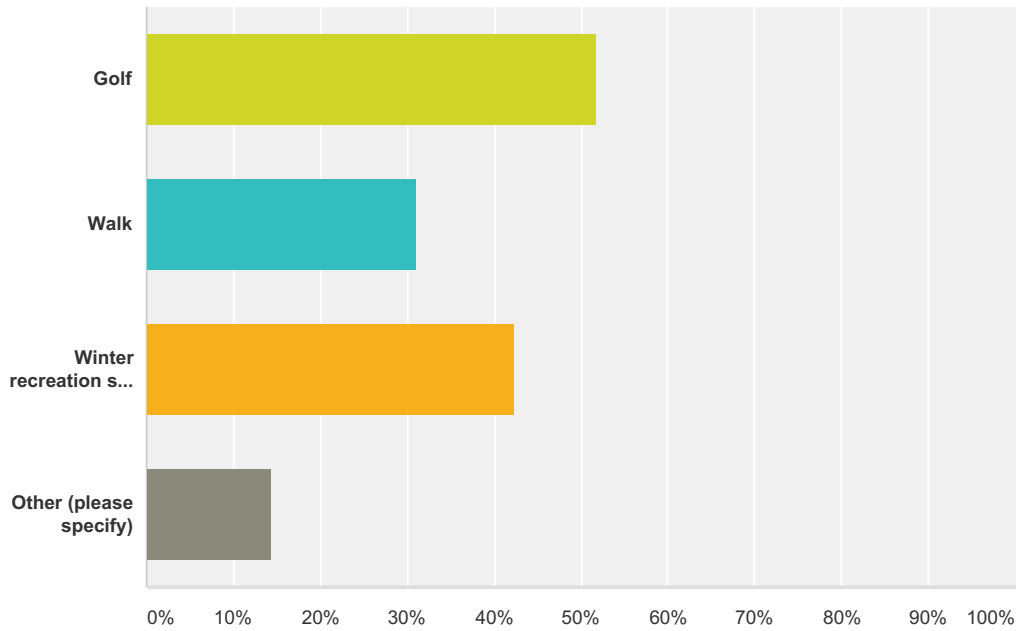

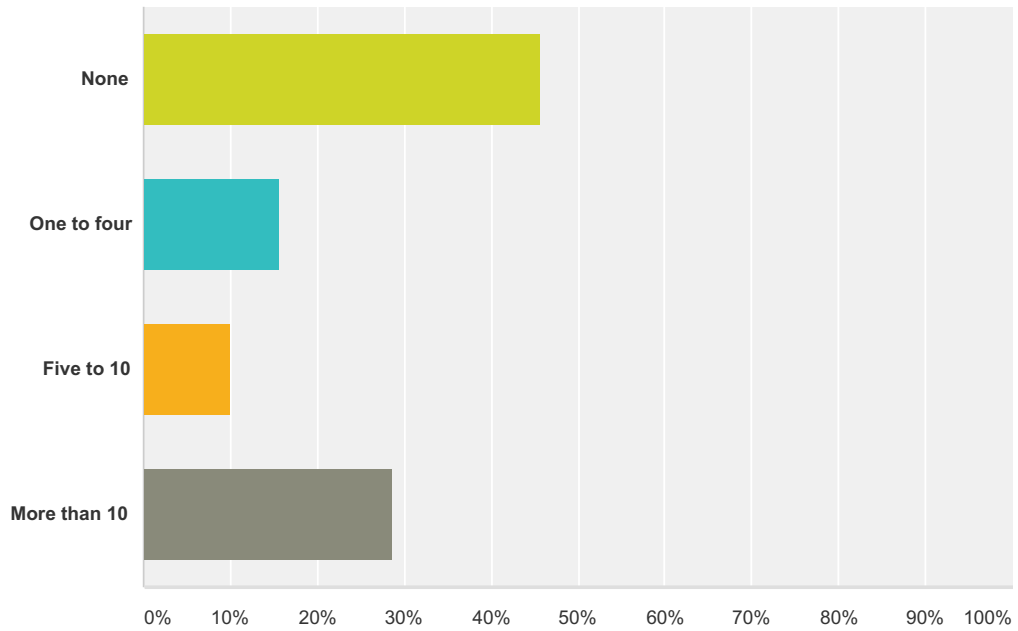

The fence is abrasive, and it creates a huge, harmful barrier in the neighborhood that cuts off the connections between the neighbors, the golfers, and the greater park system. A fence is not necessary for an urban golf course. The golf course at Lake Phalen in St. Paul is an example of a course adjacent to a comparatively dense residential area that is not barricaded by a fence. The removal of the fence would provide a more enjoyable playing experience for the golfers because they would have a better view of the beautiful homes and neighborhoods that surround the course. It would be also be a benefit to the neighbors who walk around the course so they could watch people play golf and have an unobstructed view of the beautiful course and lake. Removing the fence could even have a ripple effect by adding value to the golf course while adding value to surrounding properties. The homes surrounding the course would have an improved view of the public park system, and the golfers that play at the course would have a better view of the homes. This could boost demand of these homes, and possibly boost local use of the course by exposing more neighbors to a pleasant view of the golf course. Increasing property values will benefit the Hiawatha golf course because it will add to tax revenues that go to the park board that ultimately helps support the golf course. No fence is necessary around Hiawatha golf course. Creative landscaping with low shrubs and rain gardens could be used to deter people from cutting across the course.
