The local neighborhood organization (Kenny Neighborhood Association and Windom Community Council (Windom has no other neighborhood parks within in boundary)) was provided opportunity to comment on the Draft CE Plan prior to and concurrent with the plan's submittal to the Board of Commissioners, and prior to initiation of community engagement activities.

#### 1. <u>Project Description</u>

#### 1a. Project Overview:

This project will design and construct a playground, mostly utilizing the existing containers, in Kenny Park. The old equipment is showing its age and funding is provided for new playground equipment and surfacing. Additional site features may be included such as benches, shade, and picnic tables. The project will also work to resolve turf and erosion issues around the playground caused by high use.

#### 2. Project Data:

**2a. What are the boundaries of the community engagement area?** (For regional facilities include neighborhoods adjacent to the park and city/regional boundaries)

For this project, the Kenny and Windom neighborhood boundaries will be used as the community engagement area, specifically related to neighborhood organization engagement. Windom is included because Kenny Park is the closest MPRB-owned neighborhood park that does not require crossing under I-35W. Windom neighborhood does have a small park and recreation center called Windom South Park however, this property is owned by Minneapolis Public Schools and MPRB has a Use Agreement that allows the park and recreation center to function as an MPRB asset. However, the Windom South Park outdoor space is small and in need of an upgrade, though the park is not listed on the 6-Yr Capital Improvement Program. The more detailed engagement activities will focus on the two schools adjacent to Kenny Park and the Kenny Parent Foundation that has already completed significant engagement around playground improvements in Kenny Park.

#### Analysis:

The Kenny and Windom neighborhoods tend to be generally whiter, older, wealthier. These neighborhoods have lower populations that speak languages other than English in the home and have less people with disabilities.

# 2c. List any key findings or excerpts from relevant plans or policies that are informing this project, program or initiative, especially if community was engaged in the policy or plan:

The project will be primarily guided by the adopted Southwest Service Area Master Plan which calls for the playground in Kenny Park to remain in its current location. The master plan specifically notes that, "play areas will be somewhat expanded when improved." Additionally, the master plan notes, "next to the play areas are a small grass area and a popular gaga pit. These areas are heavily used, as evidenced by erosion in the turf which becomes quite muddy after it rains. School staff, parents, and neighbors have all expressed interest in a refresh of this area to manage drainage and erosion concerns. A wellused half basketball court sits at the south end of the play area."

# 2d. What are the data gaps? What additional research needs to be done to understand the project stakeholders and project scope?

The proximity of two schools, one an elementary school and one a middle school will offer ample opportunities to engage the local youth around the design of the new playground. The existing work of the Kenny Parent Foundation will be key to the improvements project as well. Engagement with the neighborhood organizations, the schools and the parent foundation is expected to be sufficient for a project of this type and scale.

#### 5g. Were there any barriers to successful implementation of your CE Plan?


The schedule and pandemic were the greatest factors affecting engagement for this project.





### Q9 I identify my ethnicity as (select all that apply)





## Q10 I identify my gender as...


